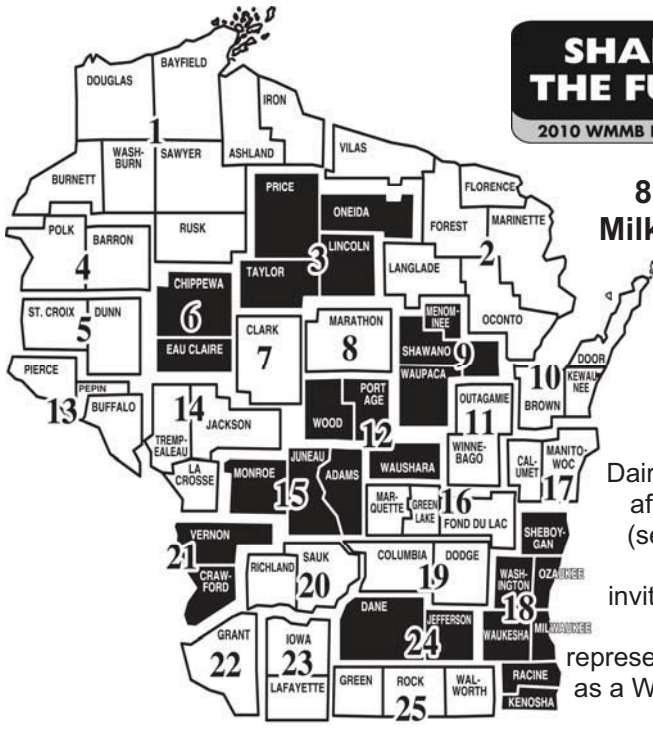

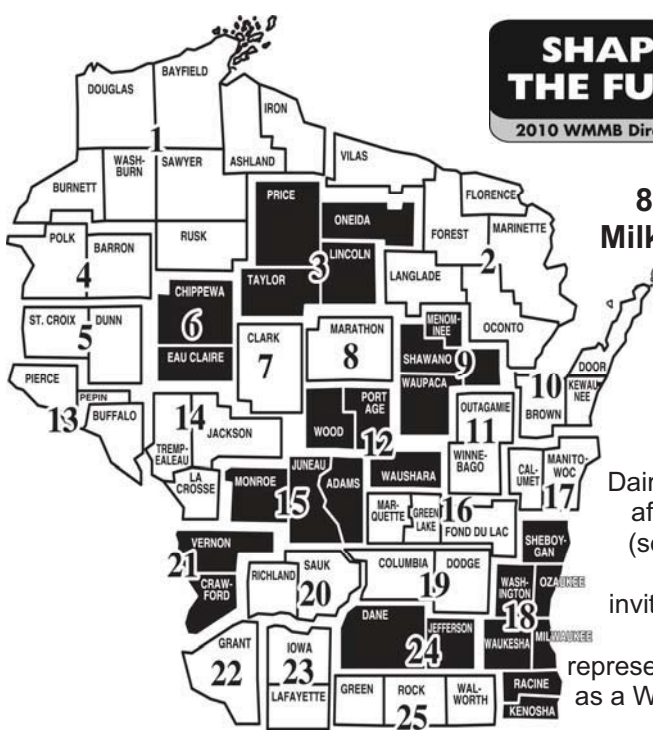

**If you are a dairy producer interested in running for a Wisconsin Milk Marketing Board director seat, the nomination period is open now through February 27, 2010.**

**Wisconsin's milk marketing order** requires the election of a portion of the marketing board each year. Eight director positions representing the following districts are up for election in 2010: 3, 6, 9, 12, 15, 18, 21, 24 (refer to map on postcard front to view affected counties). Elections will take place April 12-24, 2010. Elected directors will serve a three-year term beginning July 1, 2010, through June 30, 2013. **Only affected producers are eligible to nominate a director or be nominated.** "Affected producer" is defined as an individual, partnership or other business entity in Wisconsin engaged in the production and sale of milk.

Once the requested form is received or downloaded, the nominee
